## **Membership Admissions Procedures**

Congratulations! We are excited that you have been invited into the membership of Everett Golf & Country Club. We welcome the opportunity to process your application. Outlined below is the admissions process for all membership applicants.

### Submit your application

- Complete your application in full (incomplete applications may be rejected).
- Have your two sponsors sign your application. Sponsors may not be husband and wife.
- Submit your application to the club's Membership Director with the required deposit / initiation fee (fee varies based on type of membership being applied for).

#### **30 Day Posting Period**

Upon receipt of the completed application and deposit, the club's Membership Services Director will initiate the mandatory 30 day posting period. This posting period allows EG&CC members an opportunity review who has placed an application for membership.

#### **Credit Report**

A credit report is required of all membership applicants. Credit score and history will be taken into account when considering applications for membership. Everett Golf & Country Club has a minimum credit score requirement of 650. Specifics on credit information and history will not be disclosed to any members, nor will your social security number.

#### **Committee and Board Reviews**

- During the 30-day posting period your application will first go before the Membership Committee for review. The Membership Committee will make their recommendations on acceptance to the Board of Directors.
- Certificate Membership Applicants: All applicants for EG&CC's Certificate Membership will be contacted by a member of the Vetting Committee for purposes of scheduling an in-person interview. This interview must be conducted prior to forwarding the application to the Board of Directors for final review. The Vetting Committee will file a report of their recommendations with the Board of Directors.

• Following review by the Membership Committee (and Vetting Committee if a Certificate applicant) the application will be set before the Board of Directors for final review and consideration.

Following Board review you will be contacted by the Membership Director who will notify you of the status of your application.

#### **Approved Membership Start Date**

- Following the successful completion of the above listed steps (Board approval and the
  expiration of the 30-day posting period) you will be contacted by the club's Membership
  Director for the purposes of scheduling a New Member Orientation, preferably prior to
  the start date of your membership. If you are a new golfing member you will also be
  scheduled to meet with one of the Golf Professionals for the purpose of a Course
  Orientation.
- EG&CC activates new member accounts twice per month: the 1<sup>st</sup> of the month and the 15<sup>th</sup> of the month. Your start date will be determined by the date that your 30-day posting period expires.
