Preview Membership Agreement

Conditions of Preview Relationship:

I, _____, hereby apply to preview the following membership:

- Family Certificate Member – with Spouse (age 40+) Individual Certificate Member (age 40+)
- Family/Individual Intermediate Member (age 33-39) Social Member
- Family/Individual Intermediate Member (age 27-32) Social Executive Member
- Family/Individual Intermediate Member (age 21-26)

I understand there shall be no initial initiation fee due upon submission of my Application for Membership, in conjunction with my preview membership term. By electing to join in a provisional preview relationship, I agree to the following terms/conditions as they relate to joining Everett Golf & Country Club.

1. **Commitment to membership for a minimum preview term of 12 months.** I hereby obligate myself for the payment of all applicable monthly dues, fees and all charges during my minimum preview membership term, subject to the terms associated with the “Discover Everett Golf & Country Club” Preview Membership Initiative.
2. **Termination of privileges or membership continuation at conclusion of the preview membership term.** After my 12 month preview term has concluded, all of my privileges hereunder shall terminate **unless I elect to do one of the following:**
 - a. **On or before the 60th day of the preview term,** pay the “Discover Everett Golf & Country Club” Preview Membership Initiative initiation fee for the applicable membership category shown below:

Social Member	\$1,000	\$20
Social Executive Member	\$200	\$15

Intermediate members, upon turning age 35, must notify the club if they would like to become a Certificate member. If so, the Intermediate Member will be charged \$1,000 per year toward the \$6,000 Certificate membership. An Intermediate member joining after the age of 35 will be charged \$1,000 per year and at age 40 will owe the difference between initiation fees paid, and the \$6,000 Certificate membership.

New members choosing to take advantage of the preferred initiation fees listed above, on or before the 60th day of the preview term, will be able to pay their applicable initiation fee with a convenient staged payment schedule as follows:

- 1/2 within 60 days of application
- 1/2 on or before 1st anniversary

By making the first installment payment of the initiation fee, the new member is obligating themselves to the second installment and all the rights and responsibilities of Certificate Membership as detailed in the club by-laws.

b. After the 60th day of previewing and on or before the conclusion of the preview term, pay the initiation fee in full for the applicable category of membership as shown below. Monthly credits will not be available.

3. **Privileges and limitations during preview period.** During my preview relationship, in the event I do not become a member of the Club under 2.a. above, I shall be entitled to the use of the Club facilities and involvement in all Club activities (excluding major Club tournaments/events as determined by Everett Golf & Country Club) and usage privileges in the category of membership in which I am approved. Additionally, I understand my preview relationship is not transferable or refundable.
4. **Everett Golf & Country Club By-Laws and Rules.** I agree to be bound by the By-Laws and Rules as established and may be amended by Everett Golf & Country Club, from time to time.
5. **Revocable Membership.** The Club has the absolute right and discretion to revoke my membership at any time before the preview relationship terminates (12 months). If the Club exercises its right, I remain obligated and promise to pay all applicable dues, fees and all charges incurred through the date on which the Club exercises its right to revoke my membership.
6. **Final interpretation.** The Club reserves the right to make final decisions pertaining to all matters regarding the “Discover Everett Golf & Country Club” Preview Membership Initiative.
7. **Credit Card Authorization for past due accounts.** I agree to maintain a current credit card account on file with the Club at all times. Should my account become delinquent, I agree the Club shall have the right to bill such past-due amount and all future charges to my credit card.
