Preview and Discover Everett Golf & Country Club

We would like you to experience, first-hand, everything we have to offer at Everett Golf & Country Club. Our goal is to prove that you belong here and that we will do everything we can to make you feel at home. You will have the privilege of “**previewing**” the Club **for 12 months without the payment of an initiation fee**. During your preview term, the only responsibility you have will be the dues, fees and charges applicable to the category of membership in which you are approved.

Should you decide to purchase your membership **within 60 days of application**, you will enjoy the ability to pay your applicable initiation fee with staged payments (for Certificate Members) and both you and your sponsor will enjoy monthly credits for up to 24 months (based upon the category of membership in which you are approved).

Family Certificate Member –with Spouse (age 40+)	\$6,000	\$100
Individual Certificate Member (age 40+)	\$6,000	\$80

Family/Individual Intermediate Member (age 27-32)	\$1,000	\$50
Family/Individual Intermediate Member (age 21-26)	\$1,000	\$40
Social Member	\$1,000	\$20
Social Executive Member	\$200	\$15

Intermediate members, upon turning age 35, must notify the club if they would like to become a Certificate member. If so, the Intermediate Member will be charged \$1,000 per year toward the \$6,000 Certificate membership. An Intermediate member joining after the age of 35 will be charged \$1,000 per year and at age 40 will owe the difference between initiation fees paid, and the \$6,000 Certificate membership.

Staged Payment Opportunity

New Certificate Members purchasing their membership within 60 days of application, may pay their initiation fees with the following payment schedule. All other initiation fees shall be due in full within 60 days:

- 1/2 within 60 days of application
- 1/2 on or before 1st anniversary

By making the first installment payment of the Certificate Membership initiation fee, the new member is obligating themselves to the second installment and all the rights and responsibilities of Certificate Membership as detailed in the club by-laws.

Seasonality Element and Waived Dues Structure

We recognize this marketing initiative is being introduced during our winter season. Rather than suggesting your friends wait until spring to consider joining Everett Golf & Country Club, we are offering a modified dues structure from the beginning of the program through March 31, 2019. All individuals who apply, and are accepted for their applicable membership, will pay **no dues until April 1, 2019**.

Additional Information

- #1. A potential new member receiving this exclusive invitation from a referring member must follow the normal procedures of joining Everett Golf & Country Club; i.e., submitting all required admission documents and approval by the club.
- #2. Upon payment of the applicable preferred initiation fee within 60 days of application, both the sponsoring member and new member shall begin to enjoy applicable monthly credits, subject to the category of membership in which the new member is approved.
